



## 2017 SEMI-PRO APPLICATION

A Semi-Pro card will be issued to Permit Members who have fulfilled their Permit status in a major event.

The dues for a **Resident Semi-Pro** membership are **\$525.85**. (\$482.00+ \$25.00 Annual Assurance Fee + \$18.85 GST)

The dues for a **Non Resident Semi-Pro** membership are **\$533.20**. (\$489.00 + \$25.00 Annual Assurance Fee + \$19.20 GST)

A new semi-pro card will not be issued until a **NOTARIZED Application Form, Declaration of Eligibility** and **Member History Form** have been filed with the C.P.R.A. office and payment is received in full. In the case of a minor, both parents or the legal guardian(s) must sign the application and it must be so indicated before it is notarized. All memberships must be **purchased two business days prior** to an entry opening date before an entry will be accepted for a rodeo.

Each Semi-Pro Member will receive a subscription to Canadian Country Cowboy and Life and Dismemberment insurance through the C.P.R.A.'s Insurance policy. A summary of the terms of the policy will be forwarded to you with your membership card.

Semi-Pro Members are entitled to enter all C.P.R.A. events that are not restricted to Full Members of the Association. The Semi-Pro Member will be permitted to compete at non-sanctioned events. However, a **\$100.00 fine** will be assessed to any Semi-Pro Member who turns out of a C.P.R.A. sanctioned event to compete at a non-C.P.R.A. sanctioned event.

### Rule Section I(A)(11)

*"When the qualification of one thousand dollars (\$1,000) in one (1) rodeo season is filled, a semi-pro member will have the option to purchase a full membership. The one thousand dollars (\$1000) must be won on the members' semi pro card. No money won on a permit will be carried forward to count towards a full membership. If a semi-pro member elects to purchase a full membership at this time, earnings will be carried over to the full membership and count towards the current standings. If a semi-pro member does not purchase full membership and continues to compete on a semi-pro card, no earnings will be transferred to a full card later in the rodeo season. The Association will not advise semi-pro's when their card is filled, this is the individual's responsibility."*
