2025 DIGITAL MEDIA CREATOR MEMBERSHIP APPLICATION

The dues for a <u>Digital Media Creator</u> membership (previously a Photographer membership) are \$257.25 (Canadian Funds) and must be renewed yearly (\$250.00 + \$7.25 GST)

Memberships purchased on or before January 31st are eligible for a \$10 discount. Memberships purchased on or after March 1st will be charged \$20 late fee.

This membership will include Life and Dismemberment insurance through the CPRA's Insurance policy. If you are 80 years and older, you are not eligible for member insurance and must sign off on the declaration on the application form.

To apply for membership, you must submit the portfolio as outlined in rulebook Section I(D)(6), the non- refundable \$250 review fee, as well as a completed **NOTARIZED Application Form** filed with the CPRA office. A new membership will not be issued until you have been **approved by the standards set in the CPRA rulebook** (please refer to our rule book Section I(D)(6), and membership fees are received in full. All memberships must be **purchased two full business days prior to** working a CPRA sanctioned rodeo.

Your CPRA card is good for admission to the rodeo grounds only and does not include seating considerations. The companion pass does not entitle its holder to media credentials of any type. Some rodeo committees may elect not to admit all cardholding Digital Media Creator and /or their companions. Any special considerations for the cardholder will be the responsibility of the local committee. Arena access is dictated by either the rodeo committee or the arena director. Your Digital Media Creator card does not guarantee you arena access at any CPRA rodeo. Local committees and/or arena directors will be asked to report any Digital Media Creator who do not cooperate or comply with that rodeo's policy.

The CPRA will not be responsible for notifying specific rodeo committees of your plans to attend. However, committee contacts are available through the office. It is suggested that you contact all rodeos you wish to work at least 30 days in advance.

With the exception of hats, western attire is requested while in a CPRA rodeo arena. Hats may occasionally be required by some rodeo committees. As cardholders, you are requested to support this policy. Members of the press, at the discretion of the committee, may not have to adhere to the CPRA dress code.

Renewing members can complete their renewals through their online member account or through the CPRA office by phone, fax, email or mail and completing the renewal form.
