

2025 NEW FULL CARD MEMBERSHIP APPLICATION

The regular dues for a **Full Card** membership are **\$500.85** (Canadian Funds) and must be renewed yearly. (\$482 + \$18.85 GST)

Memberships purchased on or before January 31st are eligible for a \$10 discount. Memberships purchased on or after March 1st will be charged \$20 late fee.

A new membership will not be issued until a **NOTARIZED Application Form and Declaration of Eligibility** have been filed with the CPRA office and payment is received in full. **In the case of a minor, both parents** or the **legal guardian** must sign the application and it must be so indicated before it is notarized. All memberships must be **purchased two full business days prior** to an entry opening date before an entry will be accepted for a rodeo.

All regular members will receive Accidental Death and Dismemberment insurance through the CPRA's Insurance policy. If you are 80 years and older, you are not eligible for member insurance and must sign off on the declaration on the application form.
