

2025 NEW PERMIT MEMBER APPLICATION

The regular dues for <u>Permit</u> are \$397.88 (Canadian Funds) and must be renewed yearly. (\$355.80 + \$25.00 Annual Assurance Fee + \$17.08 GST)

Memberships purchased on or before January 31st are eligible for a \$10 discount. Memberships purchased on or after March 1st will be charged \$20 late fee.

Non-members may apply for a permit from the Association to contest at ONLY those CPRA approved rodeos where permits are accepted. Permit holders are automatically bound by all Association rules while competing at Association approved rodeos. No rodeo is required to accept entries of permit holders.

A new permit will not be issued until a **NOTARIZED Application Form and Declaration of Eligibility** have been filed with the CPRA office and payment is received in full. **In the case of a minor, <u>both parents</u>** or the <u>legal guardian</u> must sign the application and it must be so indicated before it is notarized. All memberships must be *purchased two full business days prior* to an **entry opening date** before an entry will be accepted for a rodeo.

Rule Book Section I (E)(2)

"Permit holder has the option of purchasing a **Full Card or Semi-Pro** membership with the Association after accumulation of one thousand dollars (\$1,000) in one of the major events in an unlimited number of rodeo seasons."

Rule Book Section I (E)(1c)

"in order to compete on a permit in the three (3) novice events of saddle bronc riding, bareback riding and bull riding, contestants must be over 16 years of age and under 21 years as of December 31 of the year prior to membership year in question."

(i.e.): in the given year of competition, you can be 16 years old but you cannot turn 22.)

Permit holders will receive Accidental Death and Dismemberment insurance through the CPRA's Insurance Policy. If you are 80 years and older, you are not eligible for member insurance and must sign off on the declaration on the application form.

Renewing permit holders can complete their renewals through their online member account or through the CPRA office by phone, fax, email or mail and completing the renewal form.
